### Prior to Your Event

Prior to your event, we encourage you to schedule a bridal updo trial to help your stylist create an updo style customized especially for you. If possible, please bring sample photos, and any items you wish to incorporate in your final style (tiara, veil, headpiece etc.) on the day of your trial. If you have chosen Salonblu to do your makeup, please also schedule a bridal makeup trial prior to the event.

### The Day of Your Event

On the day of your wedding, please arrive at the salon FIFTEEN minutes prior to your appointment time(s). Unless instructed otherwise, the entire wedding party should arrive at the salon with CLEAN, DRY hair.

### Scheduling & Appointments

We encourage you to book your wedding well in advance so that we may accommodate everyone and finish by the Agreement “Finish Time.” We know that your plans may change, so please let us know of any changes you have as soon as possible and we will do our best to make the changes subject to appointment availability.

### Cancellation Policy

Any changes or cancellations must be made AT LEAST ONE WEEK PRIOR TO THE EVENT. Cancellation of this agreement less than one week prior to the event will result in forfeiture of your deposit. Any cancellations on the day of the event will incur a 100% charge for the scheduled service. No changes to appointment time(s) are allowed on the day of the event. Doing so may result in the loss of the appointment and/or a full charge for the scheduled services. Note: It is very important that you and your party adhere to your scheduled appointment time(s) to insure that everyone is completed by the Agreement “Finish Time.”



## Wedding Party Agreement

### Deposit & Payment

To reserve the salon the day of your wedding, a credit card deposit for approximately 25% of the estimated cost is required at the time of initial booking. The balance is due on the day of the event. You will receive a full refund of the deposit if proper notice is given. Please note that trial appointments for hair and/or makeup must be paid on the day of the trial service.
